- Preschool enrolment decreased for next year and will result in one classroom for preschool only (approx. \$40,000 budget reduction)
- 1.7% increase (net increase 4.3% after considering revenue loss from the state [grants and reduced circuit breaker])
- Wendell up \$86,693 (11.33%), New Salem up \$10,919 (1.26%)
- Voting on budget will happen in April
- Submitted MSBA grant to fix the windows with Jen and Johanna
