 - a. Joe Shea- admin for HCGIT (Group insurance trust) (provided documents)- they hire Blue Cross for the member groups. The trust is currently looking at the following issues:
 - i. 70 groups, 11,000 individuals
 - ii. 2014 unrestricted reserve 27mil- current 18mil anticipate another 2mil in claims to cover.
 - iii. Pharmaceuticals -100% increase in 4 years (6mil 12mil)
 - iv. ACA increase in taxes 1.2 mil (absorbed by trust)

 - vi. 2 years ago- discussion of benefit changes
 - vii. State GIC plan- higher premium, deductible, co-pays

- a. Submitted article on salt no decision on making this a low-salt area.
 Next town meeting December 15th, 5pm at Stoll Building contact Nancy to make public notice. Kelley will email Nina, Amy will notify Wendell Board of Health
- b. Carla- for the record- even if we disagree with the effects of using salt on the roads, everyone wants the health and safety of students at primary importance. Despite the results of the salt discussion, we all want the kids to be safe and have safe water to drink
- c. Liability -- less salt, more sand, educate drivers of 20mph, low salt zone
- d. Request to take samples following a snowstorm

G. December Items

- 1. Municipal Health Insurance M.G.L. c 32B, §§21-23 discussion and vote *
 - What happens if we do not vote for this change?
 - o If we do not agree to new terms, we *can* leave the trust- the school district would be absorbing the increase in fees from the trust
 - We will need to get quotes from other groups
 - Premium deposit- 11,000 any incurred claims 18 months past June would be settled through the deposit and towns would be responsible for paying claims
 - There is a mitigation fund (25%) to help offset hardships
 - Teachers are unhappy about the lack of communication on this subject – the decisions were made without the consult of the teachers
 - Requests from school committee to discuss started in May and went unanswered
 - Prescription drug costs a large concern- federal government sets the prescription drug plan – this plan has no "Medicare doughnut hole"
 - Request for motion to adopt benefit change Carl motions, Jack seconds
 - What are we voting on? Allows municipal group to join state GIC plan. 21 & 22 allows municipal group to make changes to benefits and share the savings (difference between what the premiums would have been and what they are) with the union in the first year 25% with the union, 75% with
 - Why can't we have this vote in June after the union contracts
 - o SC and Union have a long tradition of working very well together
 - Union will meet again tomorrow with more information from this meeting
 - Some schools are looking at MIA as an alternative trust- will match plan requests but can raise premiums after first year
 - o HCGIT has re-insurance to cover exceedingly large claims
 - o Union members may contact Joe directly
 - Can we meet the requirements through negotiation without triggering Mass Law?
 - Motion to table Carla moves, Amy 2nd passes unanimously
 - Copies of HCGIC financials will be made available to all members
