 - v. 51,000 for school choice out-hoping for 20,000 under this
 - vi. The 26,000 can be applied for future budget

 - c. FY18 budget
 - i. Bottom line is not changing (much)- fuel is steady, insurance is up 4,000- fuel saving applied to insurance
 - ii. School choice fund approx. 277,000
 - 1. Need to be more careful with this fund. Currently budgeted 40,000 over what is being brought in
 - iii. Sparsity aid from the state perhaps in fall to coordinate a town plea to the statehouse to recognize the need for this in rural populations
