 - In middle of 2 principal searches
 - Johanna speaking with Doug Tanner (fincom) worried about the levy limit and budget cap. Budget and finances are difficult in Wendell and Jen acknowledges this. First time hearing concerns from Wendell FinCom. [Law- you cannot levy more than a certain level of taxes from the town to fund the school (2.5%). The state sets the cap. Can be overridden by prop. 2.5/ Levy ceiling (\$25 per \$1000). Outcome: schools must reduce services
- D. Director of Finance and Operations
 - Bruce, Johanna, and Beth went to Boston for Rurality day. Met with senators and reps regarding plight. Met with Comerford and Whipps. Desire a larger delegation goes in future. Many adults and children from Orange were present and representatives of other Western Massachusetts school. Adam Heinz was there asking for 9 million in increased rural aide.

 - Jen met with Natalie Blais and Jo Comerford along with superintendents from other school districts
